<u>SUMMARY</u>: To provide leadership in the development of ELD and sheltered instruction in the core content areas for secondary students.

ESSENTIAL DUTIES AND RESPONSIBILITIES: Other duties may be assigned.

- Supports district curriculum, instruction, and assessment.
- Offers curricular assistance such as data disaggregation, EL strategies, and sheltering practices.
- Offers instructional assistance by observing instruction, providing feedback, modeling instruction, co-teaching and consulting with teachers to develop strong EL instructional practices at the site level.
- Plans activities related to specific lessons and/or instruction with individuals/groups of teachers.
- Helps gather materials and finds resources to support instruction at the site level.
- Assists teachers with assessment and data-related activities, such as data collection/analysis and examination of student work.
- Models/teaches/co-teaches lessons/strategies with the classroom teacher.
- Designs and uses a variety of active teaching and learning strategies to improve student performance at the site.
- Facilitates collaboration and professional growth for site level instructional personnel.
- Plans and leads site level professional development.
- Coordinates student placement of ELs and acts as a liaison with counselors and principals concerning site level scheduling.
- Coordinates site level language testing and screening.
- Participates in Child Study meetings.
- Works with EL District-wide Trainer and EL teachers to select appropriate materials and instructional delivery practices.
- Coordinates annual site level language testing and distribution of results.
- Provides site documentation for ELs such as ELAPs, Parent Notifications, and testing accommodations.
- Maintains accurate, complete, and correct records as required by law, District policy, and administrative regulations.
- Assumes personal responsibility to remain current in evidence based instructional practices and research through independent study.
- Submits periodic updates to site principal and Director of EL to document progress toward meeting site/district goals.
- Demonstrates strong interpersonal skills and abilities to work as a member of a collaborative team.
- Works well with both supervisors and other members of the team.
- Maintains consistent and punctual attendance.
- Performs other duties assigned by supervisor or administrator.

SUPERVISORY RESPONSIBILITIES: None.

QUALIFICATION REQUIREMENTS: To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill, and/or ability required. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

EDUCATION and/or EXPERIENCE: Bachelor's degree required with a minimum of three years teaching experience. ESL certification required. Demonstrated teacher leadership at the district and site level. Knowledge of state, district and classroom-based assessments.

<u>CERTIFICATES, LICENSES, REGISTRATIONS</u>: Valid Oklahoma Elementary Teaching Certificate and ESL Certification.

LANGUAGE SKILLS: Ability to read, analyze and interpret periodicals, professional journals, technical procedures, or governmental regulations. Ability to write reports, correspondence and manuals. Ability to speak effectively before administration, staff, parents and students. Ability to communicate orally and in writing.

MATHEMATICAL SKILLS: Ability to analyze and interpret statistical data to communicate clearly to teachers. Ability to apply inferences from statistical data to classroom practice.

<u>REASONING ABILITY</u>: Ability to apply common sense understanding to carry out written and oral instructions. Ability to solve practical problems and deal with a variety of concrete variables in situations where only limited standardization exists. Ability to interpret a variety of instructions furnished in written, oral, diagram or schedule form.

OTHER SKILLS and ABILITIES: Ability to apply knowledge of current research and theory to instructional program; ability to plan and implement professional development based on District objectives; ability to establish and maintain effective relationships with administrators, faculty, and parents.

<u>PHYSICAL DEMANDS</u>: The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

While performing the duties of this job, the employee is regularly required to stand and talk or hear and sometimes walk and sit.
