**SUMMARY:** Provides leadership and support to the "Response to Intervention" process by serving as a resource to the educational team and leading skill builders. Teacher will collect, interpret, and report data to school leaders.

## **ESSENTIAL DUTIES AND RESPONSIBILITIES:** Other duties may be assigned.

- Provides Leadership and Support to the "Response To Intervention" process for the school.
- Coordinates all Child Study Team Meetings.
- Ensures students are getting all necessary data points (accountability).
- Collects, Interprets, and Reports Data.
- Assists teachers to ensure the team knows and has access to best instruction practices.
- Collaborates with the educational team to apply and evaluate interventions.
- Serves as a resource to the Special Education Team.
- Uses data software tools.
- Takes all necessary and reasonable precautions to protect students, equipment, materials, and facilities.
- Employs a variety of instructional techniques and instructional media, consistent with the physical limitations of the location provided and the needs and capabilities of the individuals or student groups involved.
- Guides the learning process toward the achievement of curriculum goals and in harmony with the
  goals establishes clear objectives for all lessons, units, projects, and the like to communicate these
  objectives to students.
- Assists the administration in implementing all policies and rules governing student life and conduct, and, for the classroom, develops reasonable rules of classroom behavior and procedure, and maintains order in the classroom in a fair and just manner.
- Assesses the accomplishments of students on a regular basis and provides analysis reports to school leaders.
- Maintains accurate, complete, and correct records as required by law, District policy, and administrative regulations.
- Assessable to students and parents for education-related purposes outside the instructional day.
- Works well with both supervisors and other members of the team.
- Maintains consistent and punctual attendance.
- Performs other duties assigned by supervisor or administrator.

<u>LANGUAGE SKILLS</u>: Ability to read and comprehend simple instructions, short correspondence and memos. Ability to write simple correspondence. Ability to effectively present information in one-on-one and small group situations to staff, students, and the school community.

<u>MATHEMATICAL SKILLS</u>: Ability to add and subtract two digit numbers and to multiply and divide with 10's and 100's. Ability to perform mathematical operations using units of American money and weight measurement, volume, and distance.

**REASONING ABILITY:** Ability to apply common sense understanding to carry out written and oral instructions. Ability to interpret a variety of instructions furnished in written, oral, diagram, or schedule form.

OTHER SKILLS and ABILITIES: Ability to apply knowledge of current research and theory in specific field. Ability to establish and maintain effective working relationships with students, staff and the community. Ability to communicate clearly and concisely both in oral and written form. Ability to perform duties with awareness of all District requirements and Board of Education policies.
