Position Title: STEM Strategist Department: Teaching and Learning

Reports To: Site Principal

FLSA Designation: Exempt (Support)

SUMMARY: Provides leadership for the school site team. Facilitates and manages the STEM development, community engagement, and Out of School Time programming that lead to student achievement, stronger families and healthier neighborhoods.

ESSENTIAL DUTIES AND RESPONSIBILITIES: Other duties may be assigned.

- Recruits and supports school site advisory team that includes students, teachers, parents and community partners.
- Performs administrative tasks for the day to day management and coordination of STEM and Out of School Time activities.
- Plans and directs efforts to involve students, families and neighborhood residents in community school initiative.
- Establishes linkages with local businesses to promote their involvement in the school.
- Develops, maintains and nurtures relationships with school administration and staff, parents, family members, neighborhood residents as well as community partners.
- Develops and maintains strong working relationships with key providers of services and programs.
- Develops programs that aim to increase educational opportunities and social connections for children, families and neighborhood residents.
- Manages scheduling, oversight and evaluation of programs.
- Assists with designing and managing volunteer systems within the school.
- Represents school at community meetings and events.
- Assists in the development of annual plan and funding proposals.
- Oversees and maintains the Innovation Lab, ensuring it remains a functional hum for student's pursuits.
- Manages and maintains the school site's social media presence, ensuring consistent and engaging online communication.
- Works with various software applications, entering and retrieving data as needed.
- Works well with both supervisors and other members of the team.
- Maintains consistent and punctual attendance.
- Performs other duties as assigned by the principal.

QUALIFICATION REQUIREMENTS: To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill, physical stamina, and/or ability required. EDUCATION and/or EXPERIENCE: Bachelor's degree in social work, education, health or related field, Masters preferred, experience in community building or program planning, implementation, evaluation and organizational support, bilingual skills preferred.

<u>CERTIFICATES</u>, <u>LICENSES</u>, <u>REGISTRATIONS</u>: Oklahoma Teaching Certificate or Bachelor's Degree in social work, education, health, or a related field.

LANGUAGE SKILLS: Ability to read and interpret complex information. Ability to write routine reports and correspondence. Ability to communicate clearly before parents, staff and students.

MATHEMATICAL SKILLS: Ability to add, subtract, multiply, and divide in all units of measure, using whole numbers, common fractions, and decimals. Ability to compute rate, ratio, and percent and to draw and interpret graphs.

REASONING ABILITY: Ability to apply common sense understanding to carry out written and oral instructions. Ability to deal with problems involving a few concrete variables in standardized situations.

OTHER SKILLS and ABILITIES: Ability to build community partnerships and maintain working relationships. Proven skills in leadership, group facilitation, coordination, marketing, budgeting, data collection and evaluation. Ability to demonstrate cultural sensitivity and work with a diverse group of people. Ability to adhere to school policies and procedures. Ability to organize, prioritize, and respond to deadlines while working on multiple tasks.
